

This monthly report is intended to provide the Vernon College Board of Trustees, Vernon College Foundation Board members, as well as college faculty and staff, with updated information regarding significant college activities, issues, and accomplishments.

### College Governance - Dr. Dusty R. Johnston, President

- Board Election—Daryl Wolf, Bob Ferguson, and Ann Wilson will begin their new six-year terms as board members starting with the May 8 board meeting. Each board member will be issued a *Certificate of Election*, complete a *Statement of Office*, and take an *Oath of Office*. Following this will be approval of a new slate of officers recommended by the nominating committee which Chairman Bob Ferguson appointed at the April 10 meeting
- Tax property demolition—The City of Vernon is preparing to demolish several tax properties than have been taken because of non-payment of taxes. The City needs approval from each taxing entity prior to demolition. The Vernon College Board of Trustees approved the demolition at the April 10 meeting. The following properties are included:

- Budget 2024-2024-5 draft 1—all initial budget requests were turned in by April 1. The administrative team and other leaders spend a great amount of time in developing the first draft of the budget. A budget is simply an estimate of a series of choices. Draft 1 was committed to basing 2024-2025 tuition and fee revenue on 2023-2024 actual revenue numbers. In addition, we are still learning the new state funding system for community colleges and that makes it hard to estimate for the next budget year. THECB will put out initial drafts of funding for 2024-2025 by mid-May.

- An idea for strong consideration that I presented exactly one year ago. I know a few things that did occur and I do appreciate those, but how about more. A number of articles and recent conferences that I have attended have highlighted the need for students to feel connected. As I drove home from the Texas Guided Pathways conference, I challenged myself to think about what VC is really doing to provide the opportunity for student connection. I know we have many activities and events that students can engage, but are we really promoting, nearly insisting, that students connect. All the literature states that they want to/expect the opportunity to. At a minimum, in addition to the current functions/activities, I am proposing that each component and each division take ownership to develop and conduct one student engagement activity per semester. I am not prescribing the activity or event. I am suggesting that the event be planned and conducted with the primary goal of engaging/connecting with students in an informal fashion to make them feel welcome, comfortable, wanted, and connected to VC. If the president component, each VP component, and each division engage the respective faculty and staff to plan, coordinate, and conduct one event per semester—then VC would be providing 14 activities/events per year in an effort to assist students in feeling connected. I appreciate your consideration and look forward to your great ideas/activities.
